- 2. Once your student account is active, we will call you to set up your remote **GED Orientation and Tech Training** appointments.

<u>To sign up for GED TESTING ONLY</u>: Go to https://ged.com/ and set up an account. Then follow #1 above, but on the Underage Approval Form mark "GED test only" and send a copy of your government issued ID with your <u>completed</u> application to yamhilltesting@chemeketa.edu. You will be notified by email when your application for testing has been approved. Once approved, you may then schedule GED testing at https://ged.com/. All GED testing is scheduled through GED.com and can be taken at any PearsonVue Testing Center.
